### **Getting There**

Please be advised that M-14 is currently closed between US-23 Business Route (Main Street) and the Miller Road/Maple Road interchange, with a detour posted. Through-access is currently not available along this section of M-14. The posted detour will include US-23, I-94 and M-14.

During construction, access to both the Main Street (Business 23) and the Miller Road/Maple Road interchanges will be maintained at all times. One lane of M-14 will be open in each direction between I-94 and Miller Road and between Main Street and the M-14 junction with US-23. The project includes pavement patching between I-94 and the Huron River, resurfacing between the Huron River and the US-23/M-14 interchange, and bridge work at several locations.

# **UDM to Offer New Mandatory First Semester** Legal Research Course

University of Detroit Mercy law librarians will teach basic legal hierarchy and research techniques to all entering U.S. JD students starting this Fall semester. The two credit mandatory course, called Introduction to Legal Research and Communication, will train students in online and print research (both Michigan and federal). We will include modules on secondary sources, case law and digests, legislation, administrative law, and citator services. The course will also touch on citation, grammar and language usage, and basic legal analysis and writing. This course is a prerequisite to the legal writing courses (ALTA I & II).

As taken from the Course Proposal, the objectives are as follows: "Students who successfully complete Introduction to Legal Research and Communication will be able to:

- Demonstrate a working understanding of hierarchy of authority. (A "working understanding" suggests the ability to select appropriate authorities in different factual contexts.)
- Perform basic research (book & online) with cases, statutes, and secondary sources. (Note: "Basic research" includes case verification and search strategies.)
- 3) Properly cite cases, statutes, and secondary sources in both long and

short form using a standard guide to legal citation.

- 4) Demonstrate a working understanding of basic principles of grammar and writing.
- 5) Demonstrate a basic familiarity with common law rule identification, with analogical reasoning (with cases), and with IRAC as a tool for structuring a legal analysis."

We will teach three sections of the course. Each class meets once a week for 110 minutes. Most classes will be comprised of a lecture followed by substantial hands-on assignments. Having the initial assignments in-class allows for the librarians to best guide students at the critical initial learning phase. Librarians are now busy planning the in-class assignments. In addition, it is anticipated that some form of take-home assignment will be administered, which will force students to link concepts without having the instantaneous direction and feedback that the librarians provide in the classroom.

We are using the *Basic Legal Research Workbook*, by **Amy E. Sloan**, as a base for the hands-on assignments, and *Michigan Legal Research*, by **Cristina Lockwood** and **Pamela Lysaght**, for the textbook (which, in spite of the name, also adequately covers federal law). We anticipate administering several unannounced quizzes and we intend to craft some sort of final exam. The assignments and quizzes will provide multiple formative assessments and ample feedback. We are confident that this course will provide our students the best chance of obtaining and retaining proper research technique.

# WAYNE STATE UNIVERSITY LAW SCHOOL-ARTHUR NEEF LAW LIBRARY

We are happy to report that we have been busy since the publication of the fall Newsletter....

**American Bar Association Site Visit**. A sabbatical Site Evaluation Team visited the Law School in April. Director **Virginia Thomas** served on the Law School's ABA Self-Study Committee and coordinated the library's responses to the Site Evaluation Questionnaire. The entire law library staff assisted with preparation for the site visit. We provided information, reviewed documents, and interviews with an ABA representative. We also reviewed our library spaces to be sure we looked good for the visit.

**Moot Court**. **Beth Applebaum**, **Jan Bissett** and **Virginia Thomas** served as Moot Court Judges for the Law School-First Year Moot Court Program.

**Library of Michigan Foundation Selection Panel. Michelle Lalonde** has been appointed to the 2016 Library of Michigan Foundation Selection Panel. Each year, the Library of Michigan Foundation presents the State Librarian's Excellence Award to one Michigan library that exemplifies excellence in customer service. Michelle will serve as the academic library representative on the Selection Panel.

**Gov Docs Review Project**. For several months we have been engaged in a review of our print Federal Depository Library Program documents. During

March-April, we withdrew long runs of print Congressional Record, Federal Register, Code of Federal Regulations, and House and Senate Journals. Prior to their withdrawal, these volumes were offered to our Regional Depository Library at the University of Minnesota, and to other Federal Depository Libraries within Michigan. **Michael Samson** coordinated the necessary updates to our records. Thanks to **Mary Bonk** and **Kathryn Polgar**, we opened up 1,400 linear feet of shelf space in our basement level stacks and now have room to consolidate our historical Michigan Law Collection. Next we will be reviewing the Serial Set and other print FDLP publications that we own in digital format.

Law Faculty Scholarship Display. We have a new digital display featuring books and book chapters authored by Wayne Law faculty. The display is being run on a digital monitor in the law library's 1st floor reading room and features publications from 2009 to date. Jan Bissett created the slides and collaborated with content manager Michael Samson and facilitator Mary Bonk.

**Law Librarians of Metropolitan Detroit (LLMD).** Our law library was delighted to host the March 2016 meeting of LLMD on the 17th in the Damon J. Keith Center. Participants included 25 librarians from academic, law firm, and government law libraries in the area. The agenda included vendor relations and publication practices, and news from member libraries.

**International Federation of Library Associations (IFLA).** Initiated by **Michael Samson**, all the Wayne State law librarians are collaborating on a project for the IFLA Law Libraries section. We submitted a collaborative proposal for a paper to be presented as part of IFLA's 2016 annual conference in Columbus, OH. The session theme focuses on the role of libraries in facilitating access to justice and the rule of law. The paper is titled: Bringing Law to the Community: Facilitating Access to Justice in Metropolitan Detroit and will be presented on August 17.

On July 5, 2016, Thomas, the Library of Congress's inaugural legislative website will retire. The Thomas "Starting Point," was launched on January 5, 1995. For over twenty years the Library of Congress, tweaked and cajoled the fragile infrastructure of Thomas. It was sometimes clunky, but with so much available legislative material in one place it was worth the effort for researchers. On September 19, 2012, a new website <a href="https://www.congress.gov/">https://www.congress.gov/</a> was launched as a Beta site, in September 2014 the beta label was removed and researchers were directed to the more robust website.
