#### WSU Law Library to host 2004 MichALL Annual Meeting

For the first time in 5 years, the MichALL Annual Meeting will be held in southeast Michigan.

The Wayne State University (WSU) Law Library will host the MichALL Annual Meeting, Friday, May 21, 2004. It will take place at the Partrich Auditorium in the WSU Law School. The 250-seat facility serves as a focal point of the Law School's connection to Detroit's legal and scholarly communities.

The program for the 2004 Annual Meeting is "From ICLE to LLMC: Digital Legal Resource Initiatives in Michigan and Beyond." The meeting will feature presentations on trends and developments in digitization and information technology by Mary Hiniker, ICLE Publications Director; Jerry DuPont, LLMC Executive Director; Richard Lucas, Law Library of Michigan Digitization Project Coordinator; Jeff Trecziak, WSU Libraries Computing & Media Services Director; and Michael Samson, MichALL Vice-President and Government Documents Librarian at the WSU Law Library.

Michael Samson, coordinator of the 2004 Annual Meeting, said "This should be a timely, substantive, and interest-capturing program for all Michigan law librarians. This is why the MichALL Program Committee recommended to offer it free to all its longstanding and loyal members."

In addition to the presentations, the 2004 Annual Meeting will also include a breakfast, lunch, business meeting, coffee time and tours of the WSU Law School and Law Library.

"I am very excited about this year's meeting. Michael has designed an interesting program that will introduce us to, and update us on, some important initiatives that will impact the way we are able to serve our clients," said Jeanne Stuart, MichALL President.

#### **Directions to the WSU Law Library**

The WSU Law Library is located at 474 Ferry Mall, off of Palmer, between Second and Cass. It is five blocks South of the Fisher Building, and two blocks North of the Detroit Public Library and the Detroit Institute of Art.

#### **Coming from the EAST**

If you are traveling from the East, which includes the communities of Sterling Heights, Warren, the Pointes, and Port Huron, take I-94 West to Exit 215 C. This will take you onto the service drive, which will cross Brush, then John R, then Woodward Avenue. Proceed along the service drive until it meets Cass. Make a left turn onto Cass, crossing the overpass of I-94. The next light is Palmer. The Law Library is in this block.

#### **Coming from the WEST**

If you are traveling from the West, which includes the communities of Inkster, Canton, Livonia, Novi and Ann Arbor, take I-96 East to I-94 East (there is a ramp over the freeway). Take I-94 to the Trumbull Exit, which is Exit 214 B. Make a right on Trumbull, and proceed 1/5 mile to Warren. Turn left on Warren, and proceed east. At the third light on Warren is Anthony Wayne Drive. Turn left here, and proceed 1/2 mile north to Palmer. Turn right at Palmer. The Law Library is in this block.

#### Coming from the NORTH

If you are traveling from the North, which includes the communities of Southfield, Birmingham, West Bloomfield, Pontiac, Lake Orion and Lapeer, take I-75 South to Exit 53 A, the Warren Exit. Turn right, and proceed West on Warren to Woodward Avenue. Cross Woodward and travel one block to Cass. Turn right at Cass, and proceed North on Cass about 1/2 mile to Palmer. There is a traffic light there. Turn left onto Palmer. The Law Library is in this block.

An alternate route from the North is the Lodge Freeway. Take Lodge south to the Grand Blvd. exit, go east (left) for three blocks to Cass. Turn right on Cass, go five blocks to Palmer. Turn right -Law School/Law Library will be on your left.

#### **Coming from the SOUTH**

If you traveling from the South, which includes the Downriver communities, Monroe, and Toledo, take I-75 North to the Warren Exit, which is numbered 53 A. Turn left on Warren, and proceed

West on Warren to Woodward Avenue. Cross Woodward, and travel one block to Cass. Turn right on Cass, and proceed North about 1/2 mile to Palmer. There is a traffic light there. Turn left onto Palmer. The Law Library is in this block.

#### **Parking**

Parking is available Monday through Friday at the visitors Parking Structure 1 on Palmer across the street from the Law School. Parking cards are available for purchase at the structure and in the Law Library for \$3.00. On Saturday and Sunday, parking is available in Parking Structure 5, two blocks from the Library, on Anthony Wayne Drive. Please bring \$1.00 bills for parking and copying, as the Law Library carries no change.

## **State Law Library Reduces Hours of Operation**

The State Law Library of Michigan has reduced its hours of operation. As of January 12, 2004, the State Law Library is open 1:00-5:00 P.M., Monday-Friday. This reduction in hours is a direct result of budget constraints and staffing shortages. Previously, the State Law Library was open 9AM-5PM, Monday-Friday. On February 19, the Law Librarians of Metropolitan Detroit (LLMD) sent the following letter to Gov. Granholm, the State Librarian and the State House and Senate Appropriations Committees to address concerns over the reduction of the State Law Library's hours and its impact on services to the legal community.

Dear Governor Granholm and Committee Members:

We are members of a professional organization of law librarians from the Detroit metropolitan area. We are employed by firms, courts, universities and public law libraries. The purpose of this letter is to let you know how disheartened we all are by the recent decision to radically curtail the State Law Library's service hours.

As many of you are probably aware, the State Law Library is an important legal research resource for attorneys, students, judges, business persons, members of the public, and the legislature itself. It is a depository of public records not available elsewhere in the state or in electronic format via the Internet. Its staff is known for its excellence in research assistance and instruction.

We understand the grave financial situation that the State of Michigan finds itself in, and know that our representatives are working diligently to pass a responsible budget and find ways to improve the overall economic climate in the state. It is important to note that improving the state's economic outlook and furthering business and job growth is affected by more than just tax rates. Services matter too! In a society based on law, access to materials on which the laws are based or which help to interpret the law is a fundamental necessity for those in the legal profession, policy analysts, legislators, government administrators, and many more individuals.

Failure to provide access to the State Law Library and its staff for more than 20 hours per week comes close to violating the spirit, if not the letter, of the Library of Michigan Act. We urge all of you to commit yourselves in the current budgeting process to restoring the State Law Library to full service hours and staffing levels.

## Law Librarians of Metropolitan Detroit (LLMD)

The Law Librarians of Metropolitan Detroit (LLMD) had a productive 2003 and is on its way to having a productive 2004.

LLMD members gathered at Dickinson Wright PLLC's Detroit office in September 2003 for their initial meeting of the season. Jan Bissett and Kathleen Gamache shared "Chairperson" duties - mainly consisting of encouraging a member to host a meeting as well as coordinate the Holiday and Spring luncheons. September's meeting was primarily a social gathering with discussions of summer happenings both inside and outside

our respective work places.

The October 2003 meeting, hosted by Honigman Miller, was a lively discussion led by Trish Webster concerning librarians' salaries and status with specific emphasis on the current SLA Salary Survey.

At the November 2003 meeting, hosted by Butzel Long's Candace Goss, LLMD members discussed websites whose content had been especially helpful in recent reference/research requests. Courthouse News, Google™ News and Google™ News Alert were among those identified by attendees. A tour of the newly opened Butzel Long conference and media center followed the meeting.

West sponsored the Holiday Luncheon at the December 2003 meeting, which was hosted by Pepper Hamilton and Elizabeth Stajniak. Sponsorship insures a captive audience and attendees viewed a brief presentation by Megan Butman, Manager, Librarian Relations, Midwest Division. At January 2004 meeting, hosted by Dickinson Wright, Sylvia Arakelian from Jaffe Raitt led a discussion of the partial closing of the State Law Library and copyright policies. Trish Webster from Honigman Miller was appointed to draft a letter addressing LLMD's concerns over a reduction of the State Law Library's hours. Copyright discussion was lively but issues remain clouded at most firms.

The topic of the February 2004 meeting, hosted by Dykema Gossett and Patricia Orr, was "Marketing Our Services to Our Clients [the lawyers]." During the discussion, LLMD members addressed the following questions: How do we inform of our services and resources? What works really well? What did we try that didn't work? Any tips for marketing to the summer and new associates? There was also discussion of annual reports, web research pages and Introduction to Library/Research – packets for new arrivals. The letter regarding the partial closing of the State Law Library was approved. It was addressed to Michigan policymakers including, the Governor, legislative committee members, and the Director of the History, Arts and Libraries Department.

In March 2004 two meetings were held: the first one was hosted by Butzel Long's Candace Goss and featured a LexisNexis update presented by Matt Wagner; the second was hosted by Clark Hill and Kathleen Gamache and featured a Westlaw update presented by Megan Butman. The April/May meetings will be a luncheon soon to be scheduled. The topic will be nominations for 2004-2005 meeting coordinator.

# Oakland County Law Library Receives Donation and Plaque to Honor Dick Beer

In June 2003, the Adams – Pratt Oakland County Law Library received a \$25,000 donation from the Royal Oak High School Class of 1950. The class made the donation in honor of classmate and MichALL member Dick Beer. Despite failing health, Dick attended the presentation. He passed away on October 20, 2003 at the age of 73.

On February 2, 2004, a plaque honoring Dick Beer's lifetime achievements was dedicated in the Law Library. The plaque reads, "In memory of Richard L. Beer. For his 34 years of service to the legal profession of Oakland County as the first director of the Oakland County Law Library. The library and those who have worked with him have been greatly enriched by Richard's knowledge, dignity, integrity and dedication to public service. In a world which places high honor and success on those endowed with great physical ability, Richard has been remarkable for his transcendence of his physical limitations. Presented by the Royal Oak High School class of 1950 in recognition of their friend and classmate."

# RSS, Internet Agents, Web Services and the Library Catalog *Michael Samson, Wayne State University Law Library*

Since January 2004, the MichALL web site has been syndicating its news via RSS (Really Simple Syndication) feeds. To read more about syndication and aggregation please go to the MichALL web page posted at <a href="http://www.aallnet.org/chapter/michall/rss/rss.htm">http://www.aallnet.org/chapter/michall/rss/rss.htm</a>. On this page you will find basic information regarding real time Internet content, syndication and aggregation. A link to a small database of Internet articles on RSS is also provided on this page. This database is provided in the Internet Explorer 'mht' proprietary format. You can download it by clicking on its link from within Internet Explorer. As it is 2.3 MB in size, please allow some time for it to download (at least 30 seconds for a high speed connection; never tried it over dial-up!). Once downloaded, the RSS webliography database will display in your Internet Explorer browser in two windows: an index in the left window/frame, and article content in the right window/frame. Navigation through it is done in a PowerPoint-like fashion using the left side window (clicking on individual titles or using the 'Previous' and 'Next' text icons).

The new Microsoft OS, Longhorn, to be released in 2006, will incorporate RSS technology and Instant Messaging (IM) within the desktop. Its new file system will be based on relational data, relational databases and XML.

Now you wonder why we should care about all this!

The ILS should be the heart and only tool for our institutional Internet presence, supplanting the current redundancy seen in developing separate web pages for accessing data. Why do we pay hundreds of thousands of dollars for ILS systems, and then underutilize and undermine them with separate web pages?

For years now we've been hearing, seeing, and learning about a myriad of 'cool' things happening on the Internet and taking aim at the core of what libraries do and exist for. The Internet is the biggest database in the world. XML provides a collocation feature for all web services and information. All devices, platforms, and languages will talk to each other through XML. And XML is

nothing more than the MARC X-peranto of the Internet age. It is time to look at these technologies through the perspective of our ILS systems and find ways to integrate all these advanced web services in our catalogs. We should learn what these new technologies are and do, so that we can apply them through our public catalogs and also maximize the use of the latest ILS metadata modules. After we understand and use these new Internet agents, we can make the ILS the 'Google' news aggregator for our institutions, and the primary information hub and portal for all the library resources and services.
