- 1) First, visit <a href="http://share.aallnet.org/read/">http://share.aallnet.org/read/</a>
- 2) Enter your email address (twice if asked). Click OK.
- Next you will be brought to the 'Essentials' tab. BE SURE TO CLICK "SAVE CHANGES" or your name will not be saved.
- 4) Click the 'Advanced' tab.
- 5) Enter the password of your choice. BE SURE TO CLICK "SAVE CHANGES" or your password will not be saved.
- 6) You're done!
