President's Message

Dear MichALL Members:

The revival of our MichALL Newsletter presents the perfect opportunity to bring you this update on activities of our Executive Board and Committees, as well as other developments that impact our Association. It has been a very active year so far and the momentum promises to continue.

The MichALL Website

With its launch of a new AALLNET last spring, AALL moved to a more robust web



server. All SIS, Chapter and Caucus content was migrated to the new server. MichALL Webmaster & Listserv Administrator, Jessica Fields, was able to make needed adjustments and has done a wonderful job keeping our website current with new content.

During the Annual Meeting in July, AALL notified Chapters of additional requirements

pertaining to use of their AALL-hosted websites. First, the AALL required all Chapter listservs to be "closed" lists, necessitating an approval process for admitting members to the list. The MichALL Executive Board opted to have our Listserv Administrator admit MichALL members to the listserv in response to their individual requests. AALL also required each Chapter to post a copyright policy and a discussion list policy on its website. MichALL Listserv Rules and Conditions and the MichALL Web Copyright Statement and Release, were adopted by the MichALL Executive Board in August 2011. These policies are intended to protect both MichALL and AALL from liability claims.

The MichALL listserv is a great communication tool for our Association and I hope you will take a few minutes to sign up. You will find instructions for requesting addition to the MichALL listserv on the website at http:// www.aallnet.org/chapter/michall/listserv/index-listserv.htm.

Schaefer Chair in Matrimonial Law. At the same time, Mr. Schaefer also made a significant gift to the law library. In honor of this donation, the law library was renamed the John F. Schaefer Law Library.

Lara has been diligently leading several space planning and collection shifting projects and has continued to play an active role in our teaching and reference arenas.

We also had the opportunity in 2010 to work with MSU College of Law graduate Beth Foster as she completed a libraryschool practicum with us. After her practicum and completion of her MLIS, she stayed on until she accepted a position as research librarian at the Neef Law Library at Wayne State University.

On a final and sad note, the law college lost Professors Craig Callen and Al Storrs. They were beloved members of the law school community and welcome sight in the law library. On breaks from his research and teaching duties, Prof. Callen would frequently make rounds in the library asking students if they needed help and offering wisdom from his own course subjects as well as others. Prof. Storrs help established the MSU College of Law Tax Clinic and was always looking for the latest tax case to share with his students. WHAT'S HAPPENING AT COOLEY LAW LIBRARIES BY MELISSA EWING

In 2011 we welcomed three new faces to our Ann Arbor campus. Michelle Sawicki joined in August as circulation team

leader, Tod Schlegelmilch joined in September as circulation team leader, and Andrew "Tig" Wartluft joined as reference librarian in November. Donyele Darrough, head of circulation at the Auburn Hills branch, attended the 2011 AALL Leadership Academy, October 28-29. Also, in 2011, Aletha Honsowitz, head of public services, and Amy Ash, reference librarian, both at the Grand Rapids campus published a CALI lesson entitled Michigan Primary Resources.

In 2010, we completed the first phase of a \$6 million expansion of at our Lansing campus library. The newly opened expansion includes a study hall, accessible 24 hours a day by students, and a 43-seat student lounge. When completed, the expansion will fill the former Lansing Town Center building, a two-story structure between the Cooley Center and the Thomas E. Brennan Law Library on Capitol Avenue.

Last March, we unveiled our expanded Auburn Hills campus library at a grand opening ceremony. The expansion essentially doubles the seating, group study rooms, shelf space, and square footage of the facility. The resulting increase in total volumes brings Cooley's four-campus library system at its Ann Arbor, Auburn Hills, Grand Rapids, and Lansing campuses to more than 670,000 volumes, making it now the second largest law library in the state.

Our new branch located in Tampa Bay, Florida, will open in May of this year. The initial staff will all be current library employees moving from our Lansing branch. Bryan Van Pottelsberghe will be head of public services, Eric Hoheisel will be head of circulation, and Julie Swagart will be a circulation team leader. Last bit of news is that Cooley will implement Innovative Interfaces' Sierra Services platform in fall of 2012. The platform is a new system and not an upgrade of the existing Millennium platform. Sierra has updated usability which hopefully will make us all more efficient.
